Program Overview This program is designed primarily for students that are in **STEM, from racialized groups, or lower-socioeconomic status** 

Fundamental Education

Students in the program select a stream to help develop critical skills required for their dream role

Specialized Education

Students will learn programming skills (Python and VBA) and how to utilize tools such as Bloomberg, Capital IQ, and FactSet from industry professionals

## **Our Accelerator Program Aims to Create the Most Rigorous Learning Environment for Students**

Women in Finance Accelerator Program

While there are other programs in Canada that serve the same function, ours captures McMaster's growing business talent and best-in-class STEM students

### **Program Timeline**

### 1 Interview

Our program requires all candidates to undertake a rigorous interview process, both behavioural and technical. Additionally, students must prepare a brief stock pitch to help us gauge their skill level

## **2** Professional Development

Over the course of the year, students will be required to select a "stream" to pursue where we will focus their development. Students will receive mentors in this area, interview preparation, and resume/cover letter support

## 3 Fundamentals

In the Fall, we will focus on delivering the theory behind investing while using case-studies to help students "think". We will cover topics such as thesis creation, idea generation, portfolio theory and construction, and an overview of markets

## 4 Workshops

Throughout the year, we encourage our sponsors to host virtual or in-person sessions on unique topics. In the past, we have hosted Intro to FX Trading, Commodities Trading (Environmental Products), and more!

## 5 Investment Fund Rotations

One of our greatest differentiators is our students rotate through our Investment Council teams, providing hands on learning and the opportunity to apply their skills meaningfully. The work they do is extremely similar to internships and full time

## **6** Capstone Projects

At the beginning of the year students are assigned a stock for the year and will develop a research report and pitch. They will also compete in our trading competition and pitch their stocks at our Value Investing Challenge

### **Learning Objectives**

#### **Financial Modeling**

We combine prep courses such as the Marquee Group and our internal models to give students holistic modeling knowledge across sectors

#### **Value Investing**

Our programme aims to teach students how to evaluate businesses using the age-old value investing philosophy but is not tied to just this style

#### **Soft Skills**

Students will learn how to network and recruit for opportunities – this is critical. Our program is about nurturing grit and talent

#### **Portfolio Management**

Students will cover portfolio theory and the basics of managing a fund, working with our Investment Strategy team and on case-studies

#### Coding - Python & VBA

We offer both internal and external training so students can debug, solve problems, and utilize finance specific libraries

Women in Finance Accelerator Program

#### How do we Differentiate?

- Existing programs such Ivey WAM utilize academics to teach the educational curriculum whilst we use experienced professionals to teach and consult on curriculum
- 2. We focus on equipping students with the skills to acquire jobs, not offer them through the program otherwise, how will they survive without grit?

#### What's Changed YoY?

- We have altered the cohort side from 22 to 15, reducing the number of students and adding a STEM specific cohort. Smaller groups allow us to hone in on the best talent
- 2. We have added "streams" so students can focus on a specific area in finance
- Upgrading our curriculum to model a value-investing programme while still including other critical finance fundamentals








## **Club Population Year of Study Distribution**



## **Club Population Race/Ethnicity Distribution**








## **Board of Directors Gender Diversity**




### **Club Staff Proportion by POC**
